- 1) Every fishing vessel must be licensed to fish by the States of Jersey, Planning and Environment Department or the appropriate government department before it may fish for profit or within six months of the Certificate or Registry having been issued.
- 2) It is an offence to fish for profit without registering a fishing vessel.
- 3) The Registrar has the right to refuse/cancel registration of a fishing vessel if the vessel is deemed to be inappropriate (unsafe).
- 4) After inspection of the vessel, the Registrar will issue a Certificate of Registry.
